Active members must:

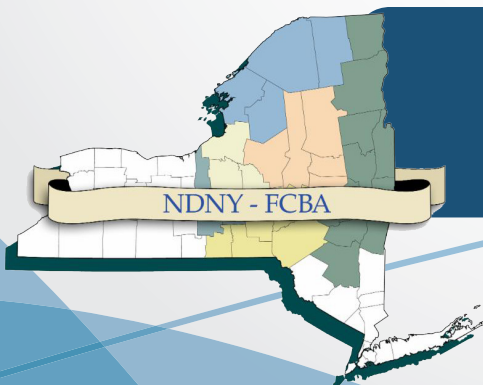
- Be an attorney in good standing in their state of admission and the *NDNY*;
